The water user shall maintain the totalizing flow meter, or other suitable measuring device, as approved by the Director, at each point of diversion (new and existing), in good working order. The water user shall allow the Watermaster access to the meters or measuring devices, provided however, where the meters or measuring devices are located within a private structure, the watermaster shall request access upon reasonable notice.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
