confirms the right to the use of water perfected under the terms of Permit S-4255. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the point of diversion from the source. The specific limits and conditions of the use are listed below.

SOURCE OF WATER: DEER CREEK, A TRIBUTARY OF ILLINOIS RIVER

PURPOSE OR USE: IRRIGATION OF 82.6 ACRES AND SUPPLEMENTAL IRRIGATION OF 2.7 ACRES

MAXIMUM RATE: 1.07 CUBIC FOOT PER SECOND

DATE OF PRIORITY: April 8, 1919

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated.

The use shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

Water use measurement conditions:

- A. The water user shall maintain the totalizing flow meter or measuring device in good working order, at the new point of diversion.
- B. The water user shall allow the watermaster access to the meter or measuring device; provided however, where the meter or measuring device is located within a private structure, the watermaster shall request access upon reasonable notice.

The water user shall maintain a headgate to control and regulate the quantity of water diverted as required by the Department.

The water user shall maintain and operate fish screening and/or by-pass devices as required by the Oregon Department of Fish and Wildlife to prevent fish from entering the diversion.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use.

This certificate is issued to describe the right modified by provisions of an order of the Water Resources Director entered 2/24/2023 and recorded at Special Order Volume 127, Page 845-846, approving a partial diminution of the right evidenced by Certificate 95471, State Record of Water Right Certificates. This certificate supersedes Certificate 95471.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
