CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

GEORGE and MARTHA FRITZ ROUTE 2, BOX 188 LEBANON, OR

confirms the right to use the waters of SOUTH SANTIAM RIVER, a tributary of WILLAMETTE RIVER for IRRIGATION of 63.7 ACRES.

This right was perfected under Permit S-20904. The date of priority is DECEMBER 10, 1951. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.7925 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
