## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WM H. HUGGARD AND BLANCHE ALICE HAHN BURNS, OR 97720

confirms the right to use the waters of MILL AND COFFEEPOT CREEKS for IRRIGATION AND SUPPLEMENTAL IRRIGATION.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Harney County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 14, at Page 531. The date of priority is DECEMBER 31, 1884.

The amount of water to which such right in entitled, for the purposes aforesaid is limited to an amount actually beneficially used for said purposes, and shall not exceed ONE-FORTIETH of one cubic foot per second per acre irrigated during each year, with a total limitation of 2.5 acre-feet for each acre irrigated, provided further that the quantity of water allowed herein, together with the quantity allowed under any other right for the same lands shall not exceed the limitation allowed herein.

A description of the land irrigated under such righty and to which the water is appurtenant (or if for other purposes, the place where such water is put to beneficial use), is as follows:
