CERTIFICATE OF WATER RIGHT

confirms the right to the use of water perfected under the terms of Permit S-40187. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the point of diversion(s) from the source. The specific limits and conditions of the use are listed below.

SOURCE OF WATER: TROUT CREEK, A TRIBUTARY OF DESCHUTES RIVER

PURPOSE OR USE: IRRIGATING 11.5 ACRES

MAXIMUM RATE: 0.25 CUBIC FOOT PER SECOND

DATE OF PRIORITY: JANUARY 13, 1976

The points of diversion are located as follows:

9 S	16 E	WM	24	NE SW	POD 1 (ORIGINAL) - 200 FEET SOUTH AND 600 FEET WEST FROM C1/4 CORNER, SECTION 24
9 S	16 E	WM	24	NE NW	POD 2 (ADDITIONAL) - 1458 FEET NORTH AND 1240 FEET WEST FROM C1/4 CORNER, SECTION 24

The amount of water used for irrigation, together with the amount of secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 6.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

The quantity of water diverted at the additional point of diversion, together with that diverted at the original point of diversion, shall not exceed the quantity of water lawfully available at the original point of diversion.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

Water use measurement conditions:

- A. The water user shall maintain, in good working order, a totalizing flow meter or other suitable measuring device, as approved by the Director, at the new point of diversion.
- B. The water user shall allow the watermaster access to the meter or measuring devices; provided however, where any meter or measuring devices are located within a private structure, the watermaster shall request access upon reasonable notice.

The water user shall maintain and operate fish screening and/or by-pass device as appropriate, at the point of diversion consistent with current Oregon Department of Fish and Wildlife (ODFW) operational and maintenance standards.


The use of water allowed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued to confirm an ADDITIONAL POINT OF DIVERSION approved by an order of the Water Resources Director entered June 4, 2012, at Special Order Volume 87, Page 712, approving Transfer Application T-11292, and together with Certificate 87603, supercedes Certificate 72479, State record of Water Right Certificates.
