confirms the right to use the waters of MARYS RIVER, a tributary of Willamette River for MUNICIPAL USE.

This right was perfected under Permit S-30130 of the State Engineer. The date of priority is NOVEMBER 5, 1964.

The amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.19 cubic foot per second, or its equivalent in case of rotation, measured at the point of diversion from the stream, and a maximum total quantity of 38.5 acre feet of water diverted during the time period April 1 to September 30 of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The point of diversion is located as follows:

Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
