The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to — of one cubic foot per second per acre, a diversion of not to exceed 3 acre-feet per acre for each acre irrigated during the irrigation season of each year. Water from the reservoir is to provide supplemental supply for lands being benefited by exchange of water with lands below the reservoir under the terms of an agreement between the Badger Improvement District and Pine Hollow Cooperative, Inc. and the Pine Hollow Cooperative Water Users Agreement. In the exchange, upper lands use water diverted from the lower lands entitled thereto and replace it in like amount from the reservoir, and the use shall conform to such reasonable rotation system as may be required by the proper state officer.
