Measurement, recording and reporting conditions:

- A. The water user shall maintain the totalizing flow meters or measuring devices, as approved by the Director, in good working order, at each point of diversion, and shall keep a complete record of the amount of water used each month and shall submit a report which includes the recorded water use measurements to the Department annually or more frequently as may be required by the Director. Further, the Director may require the water user to report general water use information, including the place and nature of use of water under the right.
- B. The water user shall allow the watermaster access to the meter or measuring devices; provided however, where the meter or measuring devices is located within a private structure, the watermaster shall request access upon reasonable notice.

The quantity of water diverted at the new point of diversion, shall not exceed the quantity of water lawfully available at the original point of diversion described as follows:

The water user shall maintain and operate the fish screen and/or by-pass device, as appropriate, at the point of diversion consistent with Oregon Department of Fish and Wildlife's (ODFW) operational and maintenance standards, to prevent fish from entering the diversions.

The use of stored water under this right is subject to the terms of conditions of contract No. 5-07-10-W1040, or a satisfactory replacement, between the Bureau of Reclamation and the water user.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Failure to comply with any of the provisions of this right may result in action including, but not limited to, restrictions on the use, civil penalties, or cancelation of the right.

The right is for the beneficial use without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

By law, the land use associated with the water use must be in compliance with the statewide land-use goals and any local acknowledged land-use plan.

The use of water allowed herein may be made only at times when sufficient water is available to satisfy all prior rights, including prior rights for maintaining instream flows.

The right to the use of the water for the above purpose is restricted to beneficial use on the place of use described.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered July 16, 2013, at Special Order Volume 85, Page 70, approving Transfer Application T-9662, and together with Certificate 86806, supersedes Certificate 83673, State record of Water Right Certificates.
