confirms the right to the use of waters as limited and conditioned below. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the point of diversion from the source.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Crook County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 1, at Page 449.

SOURCE OF WATER: NORTH FORK OF CROOKED RIVER, A TRIBUTARY OF DESCHUTES RIVER

PURPOSE OR USE: IRRIGATION OF 111.8 ACRES OF LAND, AND STOCK AND DOMESTIC USE

MAXIMUM RATE: A REASONABLE AMOUNT FOR DOMESTIC AND STOCK USE, AND 1.4 CUBIC FEET PER SECOND FROM FEBRUARY 1 TO DECEMBER 1, OF EACH YEAR FOR IRRIGATION

DATE OF PRIORITY: THE YEAR 1900

The point of diversion is located as follows:

The use here under shall conform to any reasonable rotation system ordered by the proper state officer.


