CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of A WELL in the EAST BIRCH CREEK BASIN for IRRIGATION of 4.4 ACRES.

This right was perfected under Permit G-5510. The date of priority is JANUARY 11, 1972. The amount of water to which this right is entitled is limited to an amount actually used beneficially and shall not exceed 0.06 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

The quantity of water available at the new point of appropriation (well), together with the quantity diverted at the old point of appropriation, shall not exceed the quantity of water lawfully available from the original point of appropriation described as follows:

The water user shall operate and maintain an in-line flow meter or other suitable devices for measuring and recording the quantity of water used.

Water shall be acquired from the same aquifer as the original point of appropriation.

This certificate describes that portion of water right Certificate 86784, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered APR 2 8 2023 , approving Transfer Application T-13276.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
