CERTIFICATE OF WATER RIGHT

confirms the right to the use of waters as limited and conditioned below. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the point of diversion from the source.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Grant County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 15, at Page 461.

USE: IRRIGATION OF 107.7 ACRES

RATE: A rate of flow limited to ONE-FORTIETH of one cubic foot per second per acre during the irrigation season. A quantity of water limited to one acre-foot per acre during any calendar month prior to July 1st, and thereafter not to exceed three-fourths of one acre foot per acre, and a total limitation during the irrigation season not to exceed five acre-feet per acre.

PRIORITY DATE: 1868

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The quantity of water diverted at the new point of diversion, shall not exceed the quantity of water lawfully available at the original point of diversion described as follows:

When required by the Department, the water user shall maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

When required by the department, the water user shall operate and maintain the headgate and measuring device, as needed. The water user or irrigation district shall report total flow figure when requested by the Watermaster. The Watermaster may operate the headgate and monitor the accuracy of the measuring device, as needed.

Water shall be acquired from the same surface water source as the original point of diversion.


The water user shall maintain a fish screen or fish by-pass device.

Said right shall be subject to all other conditions and limitations contained in said decree.

The right to use water for the purposes aforesaid is restricted to the lands or place of use herein described

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered August 4, 2003, at Special Order Volume 57, Page 1241, approving Transfer Application T-7795, and together with Certificate 80387, supersedes Certificate 25554, State record of Water Right Certificates.
