## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of TWO WELLS, tributary of POISON CREEK SLOUGH for IRRIGATION of 13.92 ACRES and SUPPLEMENTAL IRRIGATION of 5.12 ACRES.

This right was perfected under the terms of Permit G-297. The date of priority is APRIL 20, 1956. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.181 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the well(s).

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Water use measurement conditions:

- A. The water user shall maintain the totalizing flowmeter or other suitable measuring device as approved by the Director in good working order at each point of appropriation (new and existing).
- B. The water user shall allow the Watermaster access to the meters or measuring devices; provided however, where the meters or measuring devices are located within a private structure, the Watermaster shall request access upon reasonable notice.

The quantity of water diverted at the new additional point of appropriation (Well APOA), together with that diverted at the original point of appropriation (Well 3), shall not exceed the quantity of water lawfully available at the original point of appropriation (Well 3).

Water shall be acquired from the same aquifer (water source) as the original point of appropriation.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued to confirm a change in ADDITIONAL POINT OF APPROPRIATION approved by an order of the Water Resources Director entered MARCH 30, 2022, at Special Order Volume 122, Page 667, approving Transfer Application T-13715, and together with Certificate 96151, supersedes Certificate 89306, State Record of Water Right Certificates.
