The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, OR ITS EQUIVALENT FOR EACH ACRE IRRIGATED AND SHALL BE FURTHER LIMITED TO A DIVERSION OF NOT TO EXCEED 4 1/2 ACRE-FEET PER ACRE FOR EACH ACRE IRRIGATED DURING THE IRRIGATION SEASON OF EACH YEAR, PROVIDED FURTHER THAT THE RIGHT TO THE USE OF WATER IS LIMITED TO THE PERIOD WHEN THE FLOW OF THE ROGUE RIVER IS MORE THAN 735 CFS AT ITS MOUTH.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.
