 CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of NORTH FORK of the MIDDLE FORK of the WILLAMETTE RIVER and WATER STORED IN CATCHING RESERVOIR, CONSTRUCTED UNDER PERMIT R-605, for MUNICIPAL USE.

This right was perfected under Permit S-8519. The date of priority is APRIL 29, 1924 for 1.0 cubic feet per second (cfs); and JUNE 6, 1928 for 0.02 cfs.

The amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.02 cfs, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:

Water use measurement conditions:

- A. The water user shall maintain the totalizing flowmeter or other suitable measuring device as approved by the Director in good working order at each new point of diversion.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

B. The water user shall allow the Watermaster access to the meter or measuring device; provided however, where the meter or measuring device is located within a private structure, the Watermaster shall request access upon reasonable notice.

The quantity of water diverted at the new point of diversion shall not exceed the quantity of water lawfully available at the original point of diversion as described below:



The water user shall operate and maintain fish screen at the new point of diversion consistent with Oregon Department of Fish and Wildlife (ODFW) operational and maintenance standards. If ODFW determines the screen is not functioning properly, and is unsuccessful in working with the water user to meet ODFW stands, ODFW may request that OWRD regulate the use of water until OWRD receives notification from ODFW that the fish screen is functioning properly.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described, and is subject to all other conditions and limitations contained in any related decree; however, water may be applied to lands which are not specifically described above, provided the holder of this right complies with ORS 540.510(3).

This certificate is issued to confirm changes in POINT OF DIVERSION, PLACE OF USE, AND CHARACTER OF USE approved by an order of the Water Resources Director entered JUNE 16, 2016, at Special Order Volume 101, Page 184, approving Transfer Application T-12101, and together with Certificate 91525, supersedes Certificate 10022, State Record of Water Right Certificates.
