The quantity of water diverted at the additional point of diversion, together with that diverted at the original points of diversion, shall not exceed the quantity of water lawfully available at the original points of diversion.

The water user shall operate and maintain the fish screen at the new point of diversion consistent with Oregon Department of Fish and Wildlife's operational and maintenance standards.

The diversion must be monitored and adjusted accordingly to meet the instream water right (including 5.0 cubic foot per second from October 16, through March 31) as flow and senior rights allow.

Construction of the point of diversion must be made within the in-water work period.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.

This certificate is issued to confirm an ADDITIONAL POINT OF DIVERSION approved by an order of the Water Resources Director entered July 18, 2016, at Special Order Volume 101, Page 415, approving Transfer Application T-11986, supersedes Certificate 47952, State record of Water Right Certificates.
