Water measurement conditions:

- a) The water user shall maintain the totalizing flow meter, or, another suitable measuring device as approved by the director, in good working order, at each new point of diversion, with the exception that water rights issued to the Bureau of Reclamation, or an irrigation district (or similar entity) are not subject to the condition.
- b) The water user shall allow the Watermaster access to the meters or measuring devices; provided however, where the meters or measuring devices are located within a private structure, the Watermaster shall request access upon reasonable notice.

The water user shall operate and maintain the fish screen at the new point of diversion consistent with Oregon Department of Fish and Wildlife's operational and maintenance standards.

The right to use of the water for irrigation purposes is restricted to the lands or place of use herein described.

Rights to the use of water for power purposes are limited to a period of forty years from the date of priority of the right, as herein set forth, subject to a preference right of renewal under the laws of existing at the date of the expiration of the right for power purposes, as herby confirmed and limited.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered May 5, 2021, at Special Order Volume 120, Page 467, approving Transfer Application T-13483, and together with Certificate 95257, supersedes Certificate 3353, State record of Water Right Certificates.
