The specific limits and conditions of the use are listed below.

SOURCE OF WATER: A WELL, A TRIBUTARY OF BUTTE CREEK

PURPOSE OR USE: SUPPLEMENTAL IRRIGATION OF 1.0 ACRE

MAXIMUM RATE: 0.013 CUBIC FOOT PER SECOND

DATE OF PRIORITY: MARCH 2, 1977

The well is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use is as follows:

The water user shall maintain and operate the existing measurement devices and shall make such improvements as may be required by the Department.


The right to the use of water for the purposes aforesaid is restricted to the lands or place of use herein described.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
