confirms the right to the use of water perfected under the terms of Permit S-46219. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the well. The specific limits and conditions of the use are listed below.

PURPOSE OR USE: IRRIGATION OF 37.3 ACRES

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The quantity of water diverted at the new point of appropriation (POA Pond Sump), shall not exceed the quantity of water lawfully available at the original point of diversion (Abiqua West POD) described as follows:

Water measurement conditions:

- A. The water user shall maintain the totalizing flow meter or other suitable measuring device, as approved by the Director, in good working order, at each point of appropriation (new and existing).
- B. The water user shall allow the watermaster access to the meters or measuring devices; provided however, where any meters or measuring devices are located within a private structure, the watermaster shall request access upon reasonable notice.

The use of water under this right shall be subject to regulation consistent with other water rights from the surface water source and to all other applicable conditions and restrictions that existed at the original point of diversion.

The original date of priority shall be retained. However, if within five years after approving the transfer, the Department finds that the transfer results in substantial interference with existing groundwater rights that would not have occurred in the absence of the transfer, the well shall be subordinate to any existing right injured by the transferred water right.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.

This certificate is issued to confirm a change FROM SURFACE WATER POINT OF DIVERSION TO A GROUNDWATER POINT OF APPROPRIATION approved by an order of the Water Resources Director entered January 13, 2020, at Special Order Volume 114, Page 819, approving Transfer Application T-12969, supercedes Certificate 67686, State record of Water Right Certificates.
