The quantity of water diverted at the new additional point of diversion, together with that diverted at the original point of diversion, shall not exceed the quantity of water lawfully available at the original points of diversion.

Water use measurement conditions:

- a) The water user shall maintain a totalizing flow meter, or other suitable measuring device, as approved by the director, in good working order at the new point of diversion.
- b) The water users shall allow the Watermaster access to the meter or measuring device; provided however, where the meter or measuring device is located within a private structure, the Watermaster shall request access upon reasonable notice.

The water user shall operate and maintain the fish screen at the new point of diversion consistent with Oregon Department of Fish and Wildlife's operational and maintenance standards.

And said right shall be subject to all other conditions and limitations contained in said decree.

The right to the use of the water for irrigation purposes is restricted to the lands or place of use herein described.

This certificate is issued to confirm an ADDITIONAL POINT OF DIVERSION approved by an order of the Water Resources Director entered August 17, 2015, at Special Order Volume 96, Page 807, approving Transfer Application T-11775, supersedes Certificate 5595, State record of Water Right Certificates.
