CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

A. S. KLEINHAMMER  
BUNCOM, OR

confirms the right to use the waters of the LITTLE APPLGATE RIVER, a tributary to the APPLGATE RIVER for IRRIGATION of 55.2 ACRES, DOMESTIC and STOCK USE.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Jackson County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 4, at Page 1. The date of priority is SEPTEMBER 1, 1857, for 0.84 cfs for irrigation of 33.2 acres; 1898 for 0.55 cfs for irrigation of 22 acres, domestic, and stock use. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.39 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.

The point of diversion is located as follows:



This certificate describes that portion of water right Certificate 86646, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered August 22, 2024, finalizing Allocation of Conserved Water Application CW-134, recorded in Special Order Volume 131, Page 982. This Certificate together with Certificates 97292 and 97294 and the conserved water under CW-134 supersedes Certificate 86646, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
