CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

A. S. KLEINHAMMER BUNCOM, OR

confirms the right to use the waters of the LITTLE APPLEGATE RIVER, a tributary to the APPLEGATE RIVER for IRRIGATION of 55.2 ACRES, DOMESTIC and STOCK USE.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Jackson County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 4, at Page 1. The date of priority is SEPTEMBER 1, 1857, for 0.84 cfs for irrigation of 33.2 acres; 1898 for 0.55 cfs for irrigation of 22 acres, domestic, and stock use. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.39 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion.
