confirms the right to the use of water perfected under the terms of Permit S-32346. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the point of diversion from the source. The specific limits and conditions of the use are listed below.

SOURCE OF WATER: MIDDLE FORK TWELVEMILE CREEK, A TRIBUTARY OF TWELVEMILE CREEK

PURPOSE OR USE: RESERVOIR MAINTENANCE FOR FISH AND RECREATION IN BLACK SNAG RESERVOIR, CONSTRUCTED UNDER PERMIT R-12247

MAXIMUM RATE: 0.51 CUBIC FOOT PER SECOND AND IS FURTHER LIMITED TO A DIVERSION OF NOT TO EXCEED 82.4 ACRE-FEET DURING THE IRRIGATION SEASON OF EACH YEAR

DATE OF PRIORITY: FEBRUARY 15, 1967

Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.


When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning of construction and shall be installed under the general supervision of the Department.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.

This certificate is issued to confirm a change in CHANGE OF USE, PLACE OF USE AND POINT OF DIVERSION approved by an order of the Water Resources Director entered June 23, 1998, at Special Order Volume 52, Page 610, approving Transfer Application T-7158, and together with Certificate 75727, supercedes Certificate 51660, State record of Water Right Certificates.
