The water user shall operate and maintain an approved fish screen at the old points of diversion.

The water user shall operate and maintain an approved fish screen at the new point of diversion consistent with Oregon Department of Fish and wildlife's operational and maintenance standards.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. This right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
