The quantity of water diverted at the additional point of appropriation, together with that diverted at the original point of appropriation, shall not exceed the quantity of water lawfully available at the original point of appropriation.

Water use measurement conditions:

- a) The water user shall maintain a totalizing flow meter or other suitable measuring device approved by the director, in good working order, at each point of appropriation.
- b) The water user shall allow the watermaster access to the meter or measuring devices; provided however, where the meter or measuring devices are located within a private structure, the Watermaster shall request access upon reasonable notice.

Water shall be acquired from the same aquifer (water source) as the original point of appropriation and the Department had determined (WASC 51533) does develop the same aquifer (source) as the existing authorized point of appropriation (WASC 3413).

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.

This certificate is issued to confirm an ADDITIONAL POINT OF APPROPRIATION approved by an order of the Water Resources Director entered April 30, 2012, at Special Order Volume 87, Page 503, approving Transfer Application T-11278, supersedes Certificate 56174, State record of Water Right Certificates.
