The quantity of water diverted at the additional point of appropriation, together with that diverted at the original point of appropriation, shall not exceed the quantity of water lawfully available from the original point of appropriation.

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

The works shall include an airline and pressure gauge or an access port for a measuring line, adequate to determine the water level elevation in the well at all times.

Water use measurement conditions:

- a) The water user shall maintain a totalizing flow meter, or other suitable measuring devices, as approved by the Director, in good working order, at each point of appropriation and shall keep a complete record of the amount of ground water withdrawn.
- b) The water user shall allow the Watermaster access to the meters or measuring devices; provided however, where the meters or measuring devices are located within a private structure, the Watermaster shall request access upon reasonable notice.

Water shall be acquired from the same aquifer (water source) as the original point of appropriation.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued to confirm an ADDITIONAL POINT OF APPROPRIATION AND CHANGE IN PLACE OF USE approved by an order of the Water Resources Director entered October 8, 2010, at Special Order Volume 82, Page 64, approving Transfer Application T-11079, and together with Certificate 86618, supersedes Certificate 82605, State record of Water Right Certificates.
