The quantity of water diverted at the additional point of diversion, together with that diverted at the original point of diversion, shall not exceed the quantity of water lawfully available from the original point of diversion.

The water user shall maintain and operate a fish screen and/or by-pass device, as appropriate, at the point of diversion consistent with Oregon Department of Fish and Wildlife's operational and maintenance standards.

When required by the Department, the water user shall install, maintain and operate an in-line flow meter or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use described.

This certificate is issued to confirm an ADDITIONAL POINT OF DIVERSION approved by an order of the Water Resources Director entered May 4, 2011, at Special Order Volume 84, Page 74, approving Transfer Application T-6875, and together with Certificate 87037, supersedes Certificate 51964, State record of Water Right Certificates.
