The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the point of diversion from the source. The specific limits and conditions of the use are listed below.

A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The quantity of water diverted at the new point of diversion, shall not exceed the quantity of water (3.0 cfs) lawfully available at the original point of diversion described as follows:

The Director may require the water user to install a headgate, a totalizing flow meter, or other suitable measuring devices at the point of diversion. If the Director notifies the water user to install a headgate, a totalizing flow meter, or other measuring devices, the water user shall install such devices specified by the Director within the period allowed in the notice. Once installed, the water user shall maintain the meters or measuring devices in good working order and shall allow the Watermaster access to the meters or measuring devices.


The water user shall maintain and operate a fish screening and/or by-pass device, as appropriate, at the point of diversion consistent with the Oregon Department of Fish and Wildlife's operational and maintenance standards.

The use may be regulated if analysis of data discloses that the appropriation will measurably reduce the surface flows necessary to maintain the free-flowing character of a scenic waterway in quantities necessary for recreation, fish and wildlife in effect as of the priority date of this right or as those quantities may be subsequently reduced.

This certificate is issued to confirm a CHANGE IN POINT OF DIVERSION PLACE OF USE AND CHARACTER OF USE approved by an order of the Water Resources Director entered April 27, 2010, at Special Order Volume 80, Page 763, approving Transfer Application T-10955, and together with Certificate 86145, supersedes Certificate 81969, State record of Water Right Certificates.
