This right is limited to any deficiency in the available supply of any prior right existing for the same land.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The quantity of water diverted at the new and additional points of appropriation and diversion, together with that diverted at the original points of appropriation and diversions, shall not exceed the quantity of water lawfully available at the original points of appropriation and diversion.

Water shall be acquired from the same aquifer (water source) as the original points of appropriation.

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

Water use measurement conditions:

- a) The water user shall maintain a totalizing flow meter, or other suitable measuring device, as approved by the Director, at each point of diversion and appropriation new and existing in good working order. The water user shall keep a complete record of the amount of water used during each month and shall submit a report which includes the recorded water use measurements to the Department annually or more frequently as may be required by the Director. Further, the Director may require the water user to report general water use information, including the place and nature of use of water under the right.
- b) The water user shall allow the watermaster access to the meters or measuring devices; provided however, where the meters and measuring devices are located within a private structure, the Watermaster shall request access upon reasonable notice.

The water user shall maintain the headgate to control and regulate the quantity of water diverted, as required by the Department.

The Director may require water level or ump test every ten years.

The water user shall maintain and operate a fish screen at the new point of diversion consistent with Oregon Department of Fish and Wildlife's operational ad maintenance standards.

Failure to comply with any of the provision of this right may result in action including, but not limited to, restrictions on the use, civil penalties, or cancellation of the right.

The right to use water for the above purpose is restricted to beneficial use, without waste, on the lands or place of use described. The water user is advised that new regulations may require use of best practical technologies or conservation practices to achieve this end.

By law, the land use associated with the water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The use of water shall be limited when it interferes with any prior surface or ground water rights.

The right to the use of the water for the above purpose is restricted to beneficial use on the place of use described.

This certificate is issued to confirm ADDITIONAL POINTS OF APPROPRIATION AND CHANGE IN PLACE OF USE approved by an order of the Water Resources Director entered October 24, 2014, at Special Order Volume 93, Page 761, approving Transfer Application T-11585, supersedes Certificate 76983, State record of Water Right Certificates.
