The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the wells. The specific limits and conditions of the use are listed below.

USE: INDUSTRIAL USES

RATE: 2.0 CUBIC FEET PER SECOND (CFS), BEING 2.0 CFS FROM THE ORIGINAL WELL AND 0.9 CFS FROM THE ADDITIONAL WELL, FURTHER THE AMOUNT OF WATER USED UNDER THIS RIGHT FROM BOTH SOURCES SHALL NOT EXCEED 400 ACRE-FEET PER CALENDAR YEAR

Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The quantity of water diverted at the additional point of appropriation, together with that diverted at the original point of appropriation, shall not exceed the quantity of water available from the original point of appropriation.

The water user shall maintain an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

The well at the additional point of appropriation shall be constructed to the well construction standards in effect as of the date of this order and must include an access port.


Water shall be acquired from the same source aquifer as the original point of appropriation.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.

This certificate is issued to confirm an ADDITIONAL POINT OF APPROPRIATION AND CHANGE IN USE approved by an order of the Water Resources Director entered June 14, 1990, at Special Order Volume 44, Page 290, approving Transfer Application T-6387, supersedes Certificate 42433, State record of Water Right Certificates.
