CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

STAYTON CANNING COMPANY, COOPERATIVE
930 WEST WASHINGTON ST.
STAYTON, OR 97383

confirms the right to use the waters of NORTH SANTIAM RIVER and RESERVOIR constructed under Application No. R-52838, Permit No. R-6170, and DETROIT RESERVOIR constructed under Permit No. R-1625, a tributary of SANTIAM RIVER for IRRIGATION and SUPPLEMENTAL IRRIGATION of 138.5 ACRES.

This right was perfected under Permit S-38205. The date of priority is JANUARY 31, 1975. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 1.75 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the stream.

The points of diversion are located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from unnamed reservoir constructed under Permit No. R-6170, and Detroit Reservoir constructed under Permit No. R-1625, and is subject to the terms and conditions of contracts No. 14-06-100-8541 and No. 14-06-100-8531 between the Bureau of Reclamation and the applicant, copies of which are in the records of the Water Resources Department, and shall conform to such reasonable rotations system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
