The water user shall maintain a suitable device for measuring and recording the quantity of water diverted.

The water user shall maintain and operate the fish screen and/or by-pass device, as appropriate, at the new point of diversion consistent with the Oregon Department of Fish and Wildlife's (ODFW) operational and maintenance standards.

The quantity of water diverted at the additional point of diversion, together with that diverted at the old point of diversion, shall not exceed the quantity of water lawfully available at the original point of diversion.

The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.

The right to use of the water for the above purpose is restricted to beneficial use on the lands or place of use described; however, water may be applied to lands which are not specifically described above, provided the holder of this right complies with ORS 540.510(3).

This certificate is issued to confirm changes in ADDITIONAL POINT OF DIVERSION, PLACE OF USE, and CHARACTER OF USE approved by an order of the Water Resources Director entered JUNE 29, 2009, at Special Order Volume 78, Page 275, approving Transfer Application T-10465, and together with Certificate 85316, supersedes Certificate 80574, State Record of Water Right Certificates.
