confirms the right to use the waters of ROGUE RIVER, a tributary of PACIFIC OCEAN, for MUNICIPAL USE.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Jackson County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 16, at Page 523. The date of priority is SEPTEMBER 22, 1888.

The amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.89 CUBIC FOOT PER SECOND and 319.5 ACRE-FEET PER YEAR.

The water user shall maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted.

The water use shall maintain a fish screen or fish by-pass device, as appropriate, at the new point of diversion.

The quantity of water diverted at the new point of diversion shall not exceed the quantity of water lawfully available at the original point of diversion, being the diversion rate in cubic feet per second authorized for the right, further limited to the annual total volume of 319.5 acre feet, described as follows:

This certificate is issued to confirm changes in POINT OF DIVERSION, PLACE OF USE, and CHARACTER OF USE approved by an order of the Water Resources Director entered NOVEMBER 1, 2005, at Special Order Volume 67, Page 411, approving Transfer Application T-9900, and together with Certificate 81720, supersedes Certificate 32728, State Record of Water Right Certificates.
