confirms the right to the use of waters as limited and conditioned below. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the point of diversion from the source.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Grant County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 15, at Page 461.

PURPOSE OR USE: IRRIGATION OF 46.5 ACRES

MAXIMUM RATE: 1.163 CUBIC FEET PER SECOND

THE AMOUNT IF WATER TO WHICH SUCH RIGHT IS ENTITLED, FOR THE PURPOSED AFORESAID, IS LIMITED TO AN AMOUNT ACTUALLY BENEFICIALLY USED FOR SAID PURPOSES, AND SHALL NOT EXCEED ONE-FORTIETH CUBIC FOOT PER SECOND PER ACRE IRRIGATED TO JUNE 1 AND ONE-EIGHTIETH CUBIC FOOT PER SECOND THEREAFTER, FURTHER LIMITED TO 1.0 ACRE-FOOT PER CALANDER MONTH TO JUNE 1 AND 4.0 ACRE-FEET PER ACRE DURING SEASON APRIL 1 TO SEPTEMBER 30, MEASURED AT THE POINT OF DIVERSION.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The water user shall maintain and operate all existing measurements devices and shall make such improvements as may be required by the Department.


When required by the department, the water user shall install, maintain and operate a headgate to control and regulate the quantity of water diverted. The type and plans of the headgate must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

Said right shall be subject to to all other conditions and limitations contained in the said decree. The right to use water for the purposes aforesaid is restricted to the lands or place of use herein.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered March 14, 2008, at Special Order Volume 74, Page 394, approving Transfer Application T-10320, and together with Certificate 83694, supersedes Certificate 25901, State record of Water Right Certificates.
