CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

STATE OF OREGON
WATER RESOURCES DEPARTMENT

confirms the right to use the waters of TUMALO CREEK, CRATER CREEK, LITTLE CRATER CREEK and THREE SPRING BRANCHES, tributaries of the DESCHUTES RIVER, for instream use for conservation, maintenance and enhancement of aquatic and fish life, wildlife, fish and wildlife habitat and other ecological values.

This right was perfected under Permit S-19628. The date of priority is OCTOBER 29, 1913. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.817 CUBIC FOOT PER SECOND during APRIL 1 to NOVEMBER 1.

The description of the stream reach in which flows are to be maintained is as follows:

From the location of the diversion authorized previously under Certificate 95176, located at:

To the mouth of TUMALO CREEK, and then into the DESCHUTES RIVER to LAKE BILLY CHINOOK at River Mile 120.

This final order is subject to judicial review by the Court of Appeals under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482(1). Pursuant to ORS 536.075 and OAR 137-003-0675, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The rate and volume to be protected will be determined by the local Watermaster so the volume for each season is maximized but is not exceeded. The Watermaster's annual documentation of protected flows under Certificate 95176 shall be available for review upon request.

Within the specified stream reach, the amount of water to which this right is entitled shall not exceed the quantity of water legally available at the original points of diversion. Stream channel losses and gains calculated based on available data and the use of water by senior appropriators will determine the amount of water to which this right is entitled downstream from the original point of diversion within the specified stream reach.

The instream right established by this Allocation of Conserved Water shall replace a portion of instream water rights established pursuant to ORS 537.341 or 537.346 and shall be in addition to instream water rights established pursuant to ORS 537.348 or 537.470, unless otherwise specified by a subsequent order establishing a new instream water right.

The right is subject to all other terms and conditions of Certificate 95176, and any related decree.

This certificate is issued to confirm an ALLOCATION OF CONSERVED WATER approved by an order of the Water Resources Director recorded in Special Order Volume 133, Page 100, finalizing the conserved water under application CW-128, and modifies Certificate 95176, State Record of Water Right Certificates.
