## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

STATE OF OREGON WATER RESOURCES DEPARTMENT

confirms the right to use the waters of the LOSTINE RIVER (aka SOUTH FORK WALLOWA RIVER), a tributary of WALLOWA RIVER, for instream use for conservation, maintenance and enhancement of aquatic and fish life, wildlife, fish and wildlife habitat and other ecological values.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Wallowa County. The decree is of record at Salem, in the Order Record of the Water Resources Director, in Volume 5 at Pages 197.

The description of the quantity, priority date, and stream reaches in which flows are to be maintained are as follows:

Within the specified stream reaches, the amount of water to which this right is entitled shall not exceed the quantity of water legally available at the original points of diversion. Stream channel losses and gains calculated based on available data and the use of water by senior appropriators will determine the amount of water to which this right is entitled downstream from the original point of diversion within the specified stream reach.

The instream right established by this Allocation of Conserved Water shall replace a portion of instream water rights established pursuant to ORS 537.341 or 537.346 and shall be in addition to instream water rights established pursuant to ORS 537.348 or 537.470, unless otherwise specified by a subsequent order establishing a new instream water right.

Certificate 97432 was issued to confirm an ALLOCATION OF CONSERVED WATER approved by an order of the Water Resources Director recorded in Special Order Volume 129, Page 305, entered November 2, 2023, approving conserved water application CW-129. This correcting certificate is issued to confirm the instream water right as corrected by a correcting order of the Water Resources Director, entered MAR 6 – 2024 , and recorded in Special Oreder Volume 129, Pages 908–909 . This certificate together with Certificates 97430 and 97431 supersedes Certificate 3162 and 97432, State Record of Water Right Certificates.

The right is subject to all other terms and conditions of Certificate 3162, and any related decree.
