confirms the right to the use of water perfected under the terms of Permit S-45777. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the point of diversion from the source. The specific limits and conditions of the use are listed below.

SOURCE OF WATER: CONNER CREEK, A TRIBUTARY OF DAVIS CREEK

PURPOSE or USE: IRRIGATION OF 3.0 ACRES, SUPPLEMENTAL IRRIGATION OF 6.1 ACRES, TEMPERATURE CONTROL AND FLOOD HARVESTING

MAXIMUM RATE: 1.365 CUBIC FEET PER SECOND (CFS) MEASURED AT THE POINT OF DIVERSION FROM THE STREAM, BEING 0.228 CFS FOR IRRIGATION, 1.365 CFS FOR TEMPERATURE CONTROL, AND 0.455 CFS FOR FLOOD HARVESTING

DATE OF PRIORITY: SEPTEMBER 29, 1980 FOR ALL EXCEPT FOR 0.153 CFS FOR IRRIGATION WHICH HAS A PRIORITY DATE OF JUNE 22, 1981

The points of diversion are located as follows:

If for irrigation, this appropriation shall be limited to 1/40th of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre-feet per acre for each acre irrigated during the irrigation season of each year, for cranberries. If for the irrigation of any other crop, this appropriation shall be limited to 1/80th of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year; provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484 and ORS 536.075. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 183.484, ORS 536.075 and OAR 137-004-0080, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied. In addition, under ORS 537.260 any person with an application, permit or water right certificate subsequent in priority may jointly or severally contest the issuance of the certificate within three months after issuance of the certificate.


