CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

SAM & OPAL LOONEY
1208 OAK ST
ALBANY, OR 97321

Has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of LOONEY WELL #1, a tributary of SANTIAM RIVER for IRRIGATION of 12.7 ACRES.

This right was perfected under Permit G-538. The date of priority is APRIL 26, 1957. The amount of water to which this right is entitled is limited and hereby confirmed, for the purposes aforesaid, is limited to an amount actually used beneficially, and shall not exceed 0.16 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

Land on which water is to be used is part of that described as follows:


Part of the Robert Clelen Claim 77 in T. 11 S., R. 2 W. of the Willamette Meridian described as: Beginning at an iron pipe on the West line of and South 9.63 chains distant from the Northwest corner of Section 3, in said T. and R.; thence South 9.87 chains to an iron pipe; thence East 39.90 chains to a stone marked CS on the East line of the Northwest quarter of said Section; thence North 9.87 chains to a point which is South 9.75 chains distant from the Northeast corner of the Northwest quarter of said Section; thence West 39.90 chains to the place of beginning.

This certificate describes that portion of water right Certificate 28702, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered AUG 22 2024, approving Transfer Application T-14018.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
