CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

J. S. & ELIZA TUCKER  
TRAIL, OR 97541

confirms the right to use the waters of the ROGUE RIVER, a tributary of the PACIFIC OCEAN for the purpose of IRRIGATION OF 87.76 ACRES and SUPPLEMENTAL IRRIGATION OF 0.24 ACRE and STOCK.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Jackson Jackson County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 4, at Page 1. The date of priority is 1880.

The amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.76 CUBIC FEET PER SECOND.

A description of the place of use to which this right is appurtenant is as follows:



This certificate is issued to describe the right modified by provisions of an order of the Water Resources Director entered AUG 02 2024 and recorded at Special Order Volume 131, Page 779-780, approving a partial diminution of the right evidenced by Certificate 46673, State Record of Water Right Certificates. This certificate supersedes Certificate 46673.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
