CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of WELL 1, a tributary of SILVER CREEK (SILVER LAKE) for IRRIGATION of 11.1 ACRES.

This right was perfected under Permit G-2165. The date of priority is APRIL 11, 1962. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.14 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the well.

The well is located as follows:

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

When in the judgment of the Watermaster it becomes necessary to install headgates and measuring devices:

The pump system shall include an in-line flow meter, or other suitable device for measuring the water to which the water user is entitled;

The type and plans of the measuring device be approved by the watermaster before the beginning of construction work and that measuring device be installed under the general supervision of said Watermaster.
