CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ASPEN VALLEY RANCH LLC
GENERAL DELIVERY

confirms the right to use the waters of NEWSOME CREEK, TRIBUTARY TO CROOKED RIVER for IRRIGATION of 9.3 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for CROOK County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 1, at Page 449. The date of priority is 1879.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.12 CUBIC FOOT PER SECOND for irrigation, the total quantity being limited to 4.0 acre-feet per acre during each year, or its equivalent in case of rotation, measured at the point of diversion.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The point of diversion is located as follows:

A description of the place of use is as follows:

The quantity of water diverted at the new point of diversion, shall not exceed the quantity of water lawfully available at the original point of diversion described as follows:

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

Water use measurement conditions:

- A. The water user shall maintain, in good working order, the totalizing flow meters or other suitable measuring devices as approved by the Director, at each point of diversion.
- B. The water user shall allow the Watermaster access to the meters or measuring devices; provided however, where the meter or measuring devices are located within a private structure, the Watermaster shall request access upon reasonable notice.

The water user shall operate and maintain the fish screen at the point of diversion consistent with Oregon Department of Fish and Wildlife's operation and maintenance standards.

The right to the use of the water aforesaid hereby is restricted to the lands or place of use herein described and is subject to all other conditions and limitations contained in the decree.

This certificate is issued to confirm a change in POINT OF DIVERSION AND PLACE OF USE approved by an order of the Water Resources Director entered June 21, 2018, at Special Order Volume 108, Page 647, approving Transfer Application 12178, and together with Certificate 93828, supercedes Certificate 81327, State record of Water Right Certificates.
