confirms the right to use the waters of a well, a tributary of the WILLAMETTE RIVER, for SUPPLEMENTAL IRRIGATION of 24.5 ACRES.

This right was perfected under Permit G-7895. The date of priority is May 20, 1977. The amount of water to which this right is entitled is limited to an amount actually beneficially for said purposes, and shall not exceed 0.31 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the well.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This certificate is issued to describe the right modified by provisions of an order of the Water Resources Director entered August 10th, 2024 and recorded at Special Order Volume 131, Pages 944 945, approving the diminution of the right evidenced by Certificate 52658, State Record of Water Right Certificates. This certificate supersedes Certificate 52658.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
