confirms the right to the use of water perfected under the terms of Permit G-8306. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the wells. The specific limits and conditions of the use are listed below.

PURPOSE OR USE: IRRIGATION OF 288.4 ACRES

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

When required by the Department the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

Water shall be acquired from the same aquifer as the original point of appropriation.

The right to the use of the water for the above purpose is restricted to beneficial use on the place of use described.

This certificate is issued to confirm a change in PLACE OF USE AND POINTS OF DIVERSION approved by an order of the Water Resources Director entered November 22, 2004, at Special Order Volume 62, Page 219, approving Transfer Application 8876, supersedes Certificate 58992, State record of Water Right Certificates.
