CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ASPEN VALLEY RANCH
PO BOX 2700
POST OR 97752

confirms the right to the use of the waters of NEWSOME CREEK, a tributary of the CROOKED RIVER, for IRRIGATION of 17.1 ACRES, STOCK and DOMESTIC USE.

This right was confirmed by decree of the Circuit Court of the State of Oregon for Crook County. The decree is of record at Salem, in the Order Record of the State Water Board of the State of Oregon, in Volume 1, at Page 449. The date of priority is 1893 for 10.0 ACRES and 1903 for 7.1 ACRES.

The amount of water to which such right is entitled and hereby confirmed for the purposes aforesaid is limited to an amount actually beneficially used for said purposes, and shall not exceed a reasonable amount for DOMESTIC and STOCK USE, and 0.219 CUBIC FOOT PER SECOND for IRRIGATION from February 1st to September 15th of each year. The use hereunder shall conform to any reasonable rotation system ordered by the proper state officer.

The points of diversion are located as follows:

A description of the lands irrigated such right, and to which the water hereby confirmed is appurtenant, or, if for any other purposes, the place where such water is put to beneficial use, is as follows:

The quantity of water diverted at the additional points of diversion, together with that diverted at the old point of diversion, shall not exceed the quantity of water lawfully available at the original point of diversion.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.


The Director may require the water user to install a totalizing flow meter or other suitable measure device at each point of diversion. If the Director notifies the water user to install totalizing flow meters or other measuring devices, the water user shall install such devices specified by the Director within the period allowed in the notice. Once installed, the water user shall maintain the meters or measuring devices in good working order and shall allow the Watermaster access to the meters or measuring devices.

The water user shall maintain and operate a fish screen at the additional points of diversion as required by the Oregon Department of Fish and Wildlife.

The right to the use of the water aforesaid hereby confirmed is restricted to the lands or place of use herein described and is subject to all other conditions and limitations contained in the decree.

This certificate is issued to confirm a change in ADDITIONAL POINTS OF DIVERSION approved by an order of the Water Resources Director entered NOVEMBER 1, 2010, at Special Order Volume 83, Page 2, approving Transfer Application T-9216, and together with Certificate 81326, supersedes Certificate 594, State Record of Water Right Certificates.
