A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The water user shall maintain and operate a totalizing flow meter, or other suitable measuring device as approved by Director, in good working order, at the new point of diversion. The water user shall allow the Watermaster access to the meter or measuring devices; provided however, where the meter or measuring devices are located within a private structure, the Watermaster shall request access upon reasonable notice.

The water user shall maintain and operate fish screening consistent with current Oregon Department of Fish and Wildlife standards. Fish screening is to prevent fish from entering the diversion.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.

This certificate is issued to confirm a change in POINT OF DIVERSION AND PLACE OF USE approved by an order of the Water Resources Director entered February 6, 2018, at Special Order Volume 107, Page 617, approving Transfer Application T-11971, supersedes Certificate 36481, State record of Water Right Certificates.
