## CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of NORTH UMPQUA RIVER, tributary to the UMPQUA RIVER for IRRIGATION of 3.0 ACRES.

The right was perfected under Permit S-37976. The priority date is APRIL 13, 1973. The amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.0014 CUBIC FOOT PER SECOND for irrigation or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-TWO THOUSANDTH (1/2000) of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 0.22 acre-foot per acre for each acre irrigated during the irrigation season of each year, and is further limited to an annual volume limitation of 0.66 acre-foot per year.

A description of the place of use to which this right is appurtenant is as follows:

## Water use measurement conditions:

- a. Before the use of the Applicant's portion of conserved water, the water user shall install a totalizing flow meter, or, with prior approval of the Director, another suitable measuring device, at each point of diversion.
- b. The water user shall maintain the meters or measuring devices in good working order.
- c. The water user shall allow the Watermaster access to the meters or measuring devices; provided however, where the meters or measuring devices are located within a private structure, the Watermaster shall request access upon reasonable notice.

This certificate describes that portion of water right Certificate 45888, State Record of Water Right Certificates, REDUCED IN RATE by the provisions of an order of the Water Resources Director entered October 21, 2024, finalizing Allocation of Conserved Water Application CW-88, recorded in Special Order Volume 133, Page 236. This Certificate together with Certificates 98057 and 98059 and the conserved water under CW-88 supersedes Certificate 45888, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
