confirms the right to the use of water perfected under the terms of Permit G-1808. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the well(s). The specific limits and conditions of the use are listed below.

SOURCE OF WATER: WELL #14, A, B, AND C, A TRIBUTARY TO EAST BRANCH FOLEY SLOUGH (SILVIES RIVER)

PURPOSE OR USE: SUPPLEMENTAL IRRIGATION of 167.3 ACRES

MAXIMUM RATE: 2.09 CUBIC FEET PER SECOND (CFS), FURTHER LIMITED TO 1.03 CFS FROM WELL #14, 1.55 CFS FROM WELL A AND WELL C, AND 1.94 CFS FROM WELL B, IN ANY COMBINATION AT EACH WELL NOT TO EXCEED 2.09 CFS

A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

Measurement, recording and reporting conditions:

- A. The water user shall maintain, in good working order, a totalizing flow meter or other suitable measuring device as approved by the Director, at each point of appropriation (new and existing).
- B. The water user shall allow the watermaster access to the meters or measuring devices; provided however, where any meters or measuring devices are located within a private structure, the watermaster shall request access upon reasonable notice.

If substantial interference with a senior water right occurs due to withdrawal of water from any well listed on this right, then use of water from the well(s) shall be discontinued or reduced and/or the schedule of withdrawal shall be regulated until or unless the Department approves or implements an alternative administrative action to mitigate the interference. The Department encourages junior and senior appropriators to jointly develop plans to mitigate interference.

The water user shall ensure that the well has been assigned an OWRD Well Identification Number (Well ID tag), which shall be permanently attached to the well. The Well ID shall be used as a reference in any correspondence regarding the well, including any reports of water use, water level, or pump test data.

Dedicated Measuring Tube: Wells with pump shall be equipped with a minimum 3/4-inch diameter, unobstructed, dedicated measuring tube pursuant to figure 200-5 in OAR 690-200. If a pump has been installed prior to the issuance of this right, and if static water levels and pumping levels can be measured using an electrical tape, then the installation of the measuring tube can be delayed until such time that water levels cannot be measured or the pump is repaired or replaced.

Water shall be acquired from the same aquifer (water source) as the original point of appropriation.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.

This certificate is issued to confirm a change in POINT OF APPROPRIATION AND ADDITIONAL POINTS OF APPROPRIATION approved by an order of the Water Resources Director entered April 7, 2016, at Special Order Volume 100, Page 85, approving Transfer Application T-11906, and together with Certificate 91370, supercedes Certificate 49683, State record of Water Right Certificates.
