confirms the right to use the waters of the UMATILLA RIVER, a tributary of the COLUMBIA RIVER for IRRIGATION OF 67.0 ACRES.

This right was perfected under Permit 46568. The date of priority is JULY 31, 1981. This right is limited to not more than 1.68 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second per acre, (or its equivalent), and 4.5 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
