CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

TEEL IRRIGATION DISTRICT
32327 OREGON TRAIL ROAD
ECHO, OREGON 97826

confirms the right to use the waters of the UMATILLA RIVER, a tributary of the COLUMBIA RIVER for IRRIGATION OF 4471.30 ACRES.

This right was perfected under Permit 25924 . The date of priority is JUNE 27, 1958. This right is limited to 30.0 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second (or its equivalent), and 4.5 acre-feet for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

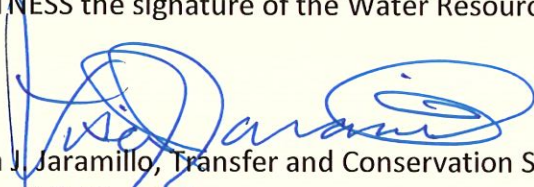
*Determination of Satisfactory Proof confirms the status of that portion of the water right for up to five years beyond the Order Date.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
