CERTIFICATE OF WATER RIGHT

confirms the right to the use of water perfected under the terms of Permit G-1501. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the well. The specific limits and conditions of the use are listed below.

SOURCE OF WATER: UPPSTAD WELL NO. 4, TRIBUTARY TO THE SANTIAM RIVER

PURPOSE OR USE: IRRIGATION OF 34.0 ACRES

MAXIMUM RATE: 0.43 CUBIC FOOT PER SECOND

DATE OF PRIORITY: DECEMBER 16, 1959

The well is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW


This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This certificate is issued in accordance with OAR 690-380-6010 to confirm the water right for a non-completed additional point of appropriation approved by an order of the Water Resources Director entered September 11, 2013, at Special Order Volume 91, Page 294, approving Transfer Application T-11316, and supersedes Certificate 87144, State record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
