confirms the right to the use of water perfected under the terms of Permit G-1738. The amount of water used to which this right is entitled is limited to the amount used beneficially, and shall not exceed the amount specified, or its equivalent in the case of rotation, measured at the well(s). The specific limits and conditions of the use are listed below.

SOURCE OF WATER: TWO WELLS IN COLUMBIA RIVER BASIN

PURPOSE OR USE: AGRICULTURE WATER USE ASSOCIATED WITH DAIRY AND IRRIGATION OF 62.8 ACRES

MAXIMUM RATE: 1.312 CUBIC FEET PER SECOND (CFS), BEING 0.527 CFS, FOR AGRICULTURE USE, FROM EITHER WELL OR IN ANY COMBINATION FROM BOTH WELLS, AND NOT TO EXCEED A TOTAL VOLUME OF 188.4 ACRE-FEET IN A CALENDAR YEAR (JAN. 1 THROUGH DEC. 31); AND 0.785 CFS, FOR IRRIGATION, FROM EITHER WELL OR IN ANY COMBINATION FROM BOTH WELLS, AND NOT TO EXCEED A TOTAL VOLUME OF 188.4 ACRE-FEET OF WATER DURING THE IRRIGATION SEASON (MAR. 1 THROUGH OCT. 31) EACH YEAR

PERIOD OF USE: YEAR-ROUND FOR AGRICULTURE USES ASSOCIATED WITH DAIRY, AND MARCH 1 THROUGH OCTOBER 31 FOR IRRIGATION

DATE OF PRIORITY: DECEMBER 19, 1960

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. The use shall conform to any reasonable rotation system ordered by the proper state officer.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The water user shall maintain and operate totalizing flow meters for measuring and recording the rate and volume of water appropriated for righted irrigation use, agricultural use for dairy, and exempt use from both wells (existing and new). The water user must be able to separate and account for the total use of each righted use and exempt use.

The water user shall submit a yearly record of the measurements from all the meters to the Watermaster, due on the 15th of January of each year for the preceding year's uses on a form provided by the Department. The report shall contain the total volume of water diverted from the wells for righted irrigation use, righted agricultural use for dairy, and exempt uses for the previous year. The Watermaster may modify the reporting requirements as needed.

The quantity of water diverted at the additional point of appropriation, together with that diverted at the original point of appropriation, shall not exceed the quantity of water available from the original point of appropriation.

Water shall be acquired from the same aquifer as the original point of appropriation.

The right to the use of the water for the above purpose is restricted to beneficial use on the place of use described.

This certificate is issued to confirm an ADDITIONAL POINT OF APPROPRIATION, PLACE OF USE, and USE approved by an order of the Water Resources Director entered September 16, 2002, at Special Order Volume 56, Page 967, approving Transfer Application T-8867, and together with Certificate 83438, supercedes Certificate 34282, State record of Water Right Certificates.
